BLACK ROCK YACHT CLUB – BOAT STORAGE AGREEMENT – September 2019

BOAT STORAGE IS ALLOCATED ON THE BASIS THAT THE MEMBER'S PRIME INTENDED USE OF A STORED BOAT IS FOR PARTICIPATION IN CLUB EVENTS.

By accepting an offer of boat, kayak, board, ("Craft") storage I accept and agree to the conditions below

- 1. This contract is valid until the completion of the current Membership Season.
- 2. I have read and fully understand this agreement and the current conditions of Boat Storage.
- 3. My craft is stored in the Club grounds at my own absolute risk and that the Black Rock Yacht Club, Inc. ("the Club") will accept no responsibility or liability for any loss or damage to the craft whilst it is so stored.
- 4. I hereby indemnify the Club against any claim whatsoever arising out of any loss of or damage to my stored vessel and agree that any insurances of my Craft will be my responsibility.
- 5. The term Craft includes trolley, cover, hull, sails, spars, paddles, and all gear relating to my Craft stored in the Club.
- 6. To pay the rental charges fixed by the Club for storage (shown on the club web page) of my craft and in addition will pay any penalty charges.
- 7. Failure to remove the craft at the request of the Club or upon expiration storage period, or the breach of membership or storage conditions, the Club the craft may remove at my own cost from the club storage facilities, or utilized at the Club's discretion.
- 8. The expectation is for craft in the yard to compete in at least 50% of the club races over a season (Kayaks and Boards exempt).
- 9. Allocation may depend on early payment and attendance at working bees.
- 10. Unallocated spaces are to remain clear at all times.
- 11. Road trailers are not to be stored in the yard.
- 12. My Craft, while stored, will have and remain on a properly maintained trolley.
- 13. During major events I may be required to remove my boat from the yard at the direction of the Club.
- 14. My Craft is to have its name visible when the vessel is in its normal position.
- 15. My Craft is to be stored in its allocated position only.
- 16. My craft shall be removed from the Club storage within 7 days of notification from the Club Committee or manager for such reasons as the club may determine including:
 - Failure to remain a financial member of the Club.
 - Failure to pay any charge imposed by the Club.
 - Failure to meet the Club's minimum sailing requirements.
 - Failure to store my craft correctly
 - Failure to enter into a new agreement on the expiration of the old one.
- 17. I will remove my Craft from Club storage within 7 days of sale of the Craft.
- 18. If sold to another member within the Club, storage rights will not transfer to the new owner until a new storage application form is signed and received by the Club from new owner.
